






GFF Framework for a People's Pact

We will soon be launching an e-consultation process leading up to the Global Futures Forum in 2023 to draft a meaningful set of recommendations and an action plan as outcomes to the GFF. This first drafting process will form an inextricable part of the final document (in 2024) which will serve as an advocacy tool and a statement of commitment from the perspective of civil society on the occasion of the Summit of the Future in 2024.

At this stage, from January - April 2023, a team of NGO, Think-Tank and Youth co-facilitators will be opening e-consultations to draft a document which will be particularly useful for advocacy and inclusion for both the SDG Summit as well as the Member State-led "Pact for the Future". We will asking participants to focus their contributions on two complementary dimensions: generating recommendations on relatively new ideas (i.e. Global Digital Compact) and building the consensus and legitimacy of ideas already generated (so as to not reinvent, but rather strengthen, the wheel). We seek to generate 3-5 strong recommendations which the 2023 GFF will advance further - moving from the 'what' to the 'how'. At least 1 or 2 of the recommendations should directly link to the SDGs to ensure this process is well linked to the SDG Summit in September 2023.

Scope: This initial drafting process will last from now through the GFF and to April to incorporate GFF discussions. The ultimate output is a coherent and focused set of recommendations on several possible topics, building on but not limited to the Secretary-General's *Our Common Agenda* proposals with an eye towards the Summit of the Future in 2024.



Guidance Note for Drafting the People's Pact Proposals

We look forward to your engagement in the crafting of the people's proposals which we plan to further interrogate at the Global Futures Forum in March of 2023. The outcomes we are looking for are 3-5 solid recommendations having broad agreement as either the most important or the most feasible (or both!) suggestions on a given topic.

This challenge is two-fold: 1. hone in on the key recommendations and 2. articulate these recommendations clearly. Because this is all part of a process, there is meant to be ample flexibility built in. For example, some recommendations may have significant detail on how to get from where we are to where we want to be, others may just be a 'good idea'. In both cases, we hope that the results from the GFF are actionable recommendations which Member States can then pursue (not just the 'what', but also the 'how').

This will come about as a result of the following processes:

- A google group e-consultation these two week consultations will each have a couple guiding questions which seek to (first week) gather relevant recommendations in a specific track and then (second week) identify those recommendations which have the greatest amount of consensus and how to take them forward.
- 2. A drafting process articulate in writing the very clear recommendation and, to the maximum extent possible, writing how that recommendation can become a reality. We will have numerous background resources available to assist with this.
- 3. The Global Futures Forum which will allow ample time to develop a roadmap for action for the selected recommendations.

The guiding questions for each consultation are, in a sense, guite simple.

- 1. What good recommendations already exist related to this track? (good may be feasibility, necessity, etc.)
- 2. Of these, which 3-5 are the most widely supported?
- 3. How do we get from where we are today to the implementation of these recommendations?

The timeline for each of the seven tracks are as follows:

January 11-24 Global Economic & Financial Architecture

January 18-31 Human Rights & Participation
January 25 - February 7 Development (HLPF, SDGs)

February 1-14 Digital Compact

February 8-21 Environmental Governance

February 15-28 Peace and Security

February 22 - March 8 UN & Global Governance Innovation
